

# Tax time 2020 and COVID-19 assistance

Happy new financial year!

The past 6 months has seen many legislation changes, challenges and subsidies offered. We have included some of the recent changes and announcements below to assist you.

### \$3,000 Small Business COVID-19 Recovery Grant

The NSW Government has another \$3,000 COVID-19 grant available for eligible small businesses to assist with the costs of safely reopening or up-scaling operations.

To be eligible the business needs to be in their list of highly impacted industries which can be found in the below link:

Due to different working arrangements as a result of COVID-19, there may be changes in what you can claim as a tax deduction this year.

For example if you have been working from home as a result of COVID-19 you may be able to claim working from home expenses. The ATO have different ways to determine your deduction.

# **Keeping records of your claims**

It's important that all records are retained for claims with the ATO as they may request substantiation to support your claims. The ATO also have an app available to enable you to keep your receipts digitally rather than paper form.

# **JobKeeper Payment**

A reminder that if your business qualified to enrol for JobKeeper, to enable your business to receive the payments you need to keep completing monthly declarations by 14<sup>th</sup> of each month until the end of the JobKeeper period.

Once your business becomes eligible and enrolled in the JobKeeper program you don't need to continue to satisfy the drop in turnover requirements. Even if your business income has increased you are still able to claim the JobKeeper payments until the program ends (currently September 2020).

If your business has only recently experienced a 30% drop in turnover you can still apply for JobKeeper Payments. If you are unsure how to determine your eligibility please contact us.

# Payroll year end - the end of PAYG Payment Summaries

With the 2020 tax year now behind us, for employers it's time to ensure your payroll reporting is completed.

Most employers will now be reporting wages via Single Touch Payroll (STP) and won't be preparing **PAYG Payment Summaries** this year. Instead they will be providing an **Income Statement** which will have all your payroll information for your tax return. Before your tax return can be completed your Income Statement will need to be 'tax ready' – which means employers have completed their finalisation.

If you are an employer with employees it is important that you have reconciled your wages with your STP reporting before you complete your finalisation with the ATO. If you are having difficulty reconciling please don't hesitate to contact us for assistance.

**For employees,** once an Income Statement is tax ready you don't need to bring us your income details, we will be able to access it via the ATO Tax Agent Portal.

#### Extension of the \$150,000 Instant Asset Write-off
